Welcome to the UGI Electric Business Rebate Program

The UGI Electric SaveSmart Business Incentive program offers incentives on a wide variety of energy efficiency projects. These incentives can help your business reduce payback time and offset the cost of energy efficiency upgrades.

Incentive amounts are effective June 1, 2024, and are calculated based on verified annual energy savings and contingent upon the final review of project details.

Pre-approval is required for all Custom and Direct Discount projects and recommended for Prescriptive projects.

Your path to savings

All business customers with facilities in our service territory are eligible to participate. We help you find the path that's right for you — from prescriptive and custom incentives to our Direct Discount and Instant Discount Programs — so you can start saving energy all year.

Prescriptive and custom incentives reduce payback time of installing energy-efficient equipment. Eligible upgrades include but are not limited to:

- · Lighting*
- · Variable Frequency Drives · New Construction (VFDs)

- · Compressed Air
- · ENERGY STAR® Certified Smart Thermostat
- · Building controls or Energy Management Systems

· Chiller or Refrigeration Process Improvement

	Direct Discount Program	\$0.12/kWh

Pre-approval is required for custom and Direct Discount projects prior to construction beginning. Pre-approval means that a project application must be submitted in good order and receive a pre-approval letter before construction begins. All projects must be submitted, with documentation in good order, within 180 days of the project completion date. Incentives are capped at 50% of the project cost, up to \$100,000. Incentives for the Direct Discount Program are capped at 75%.

Our Direct Discount Program lets small businesses with a GS1 or GS4 rate code save \$0.12 per kWh on lighting projects — covering up to 75% of the project cost.

Through our Instant Discounts for lighting program, all UGI Electric non-residential customers can get **instant discounts** on qualified lighting when you purchase from local participating distributors. Just provide your UGI Electric Utilities account number — no forms or applications required.

Your New Construction project may be eligible for incentives through our prescriptive or custom program.

Your step-by-step guide to savings

We're here to guide you through every step of the application process and help you identify the incentive or program that fits your business best. Here's how it works:

- Select your energy efficiency upgrade. Talk with your chosen contractor or reach out to us to help you identify energy efficiency upgrades that are eligible for incentives.
- Visit the UGI <u>Electric Business Rebate Program website</u> to download your application and learn how to submit your rebate.
- Reserve your funds with approval from our program team and, if required, get a pre-verification.
- **Install** your energy-efficient equipment or systems.
- **Submit** your final application and supporting documentation (itemized invoice, scope changes, etc.) as needed.
- Prepare for final review. Watch for email requests for additional documentation or a post-site verification, if required.
- **Receive your incentive check** approximately 4-6 weeks after completion of final review.
